Dr. Hallfors reviewed the existing research and evaluations of the three classroom prevention curricula that are most widely used in California and summarized that information in Chapter 1.<sup>1</sup>

**Amy Sporer, M.S.**, assisted with the review process. She is a research coordinator, under the direction of Denise Hallfors at the University of North Carolina at Chapel Hill, School of Public Health. Sporer's training is in psychology and psychometrics, primarily the psychological and psychoeducational assessment of children in schools.

**Steve Sussman, Ph.D.**, is a professor of preventive medicine and psychology at the University of Southern California, Los Angeles, and a fellow of the American Academy of Health Behavior. His major areas of research interests are drug abuse prevention, cessation, and relapse prevention; psychosocial predictors of drug use development; the role of program success expectancies; and empirical program development methodology. He is the principal investigator of numerous national research projects and the author of over 100 peer-reviewed journal articles and three books. He is currently working on an update of his review of evaluated teen tobacco-cessation programs.<sup>2</sup>

Dr. Sussman wrote the commentary about classroom prevention strategies. He focused on the social influences approach, which research has shown to be especially effective with youths.
